ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge the Minnesota State Gravel Championships ("Event") is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, lack of hydration, weather, my physical condition, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, and Event coordinators. These risks are not only inherent to Event participants, but are also present for volunteers.

I hereby assume all of the risks of participating and/or volunteering in this Event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I understand that this is an unsupported Event. I agree that I am fully responsible for myself and my actions during my participation in this Event. No support services (such as a sag wagon, mechanical assistance, and medical assistant) whatsoever are provided by the Event coordinators. If I cannot finish this Event or I am injured, I am on my own and I understand that the Event coordinators have no responsibility for sweeping the route or providing any transportation assistance.

I certify that I am physically fit, have sufficiently trained for participation in this Event and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability form ("Waiver") will be used by the Event holders, sponsors and organizers and that it will govern my actions and responsibilities at this Event. In consideration for permitting me to participate in this Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) Waive, release, and discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me, including traveling to and from this Event, the following entities or persons: Tom Bisel, Race Director; the Minnesota State Gravel Championships organizers; other Event officers, employees, volunteers, representatives, and agents (collectively referred to herein as "Releasees");

(B) Defend, indemnify, and hold harmless the Releasees from any and all liabilities or claims made as a result of my participation in this Event, whether caused by my negligence, the negligence of Releasees, or others.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this Event.

I understand that during this Event and related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the Event coordinators, holders, producers, sponsors, and assigns.

This Waiver shall be construed broadly and provide a release and waiver to the maximum extent permissible under applicable law. Any suit or action to enforce or interpret this Waiver must be brought in the state of Minnesota and shall be interpreted and enforced under the laws of the state of Minnesota.
